**43-23-12. Broker's place of business – 1.** Every person, partnership, association, corporation, or limited liability company licensed as a real estate broker is required to have and maintain a definite place of business within this state, for the transaction of real estate business. The certificate of registration as broker and the certificate of each real estate salesperson employed by such broker must be prominently displayed in said office. The said place of business must be designated in the license, and no license issued under the authority of this chapter may authorize the licensee to transact business at any other address. In case of removal from the designated address, the licensee shall make application to the commission before said removal or within ten days after said removal, designating the new location of such office, whereupon the commission shall forthwith issue a new license for the new location for the unexpired period. The broker's home may qualify as such place of business.

Notice: In the event that a broker changes his or her business name each broker, broker associate and salesperson registered under the above broker's or firm's license must have their license changed. In the case whereby a broker changes his or her business address only those brokers and broker associates registered with the firm would require a change of address. A corporation filing for a name change must submit with this application a certified copy of its amended Articles of Incorporation (obtainable from the Secretary of State's office).
