Deadline for renewal is *November 15, 2017*.

Fee: \$120.00

Failure to answer ALL questions <u>will</u> result in delayed processing and late fees. Proof of E & O insurance MUST be attached for renewal.

Non-resident & reciprocal licensees must submit a current (less than 30 days old) Certificate of Licensure with the renewal.

Section 43-23-13.1 of the North Dakota Real Estate License Law provides that all real estate licenses shall expire on the thirty-first day of December of each year. Failure to remit this annual renewal application form and fee when due will automatically cancel your license.
