 - a. Complaint #2015-14 NDREC v Bradley Haugen Stipulated Agreement.
 Special Assistant Attorney General Connie Hofland presented the signed Stipulation and Settlement Agreement from Bradley Haugen.
 Commissioner Cymbaluk moved, seconded by Commissioner Sheridan to approve the Stipulation and Settlement Agreement for Bradley Haugen where he agrees to pay \$300 in fines and \$280 in attorney fees.

4. REVIEW BROKER LICENSE ASSESSMENT LETTER REGARDING MICHAEL L. MARCOTTE. Michael M. Marcotte and Laurie K. Tweten were both present via conference call and participated in the discussion. Ms. Tweten had refused to complete the Broker Applicant Assessment form for Mr. Marcotte. Both parties were asked to present their side of the situation. Ms. Tweten was asked to keep her comments regarding personal disputes out of this discussion as it was not appropriate for this meeting. Ms. Tweten was asked if she would verbally answer the broker assessment questions to which she answered yes. She verbally answered the following questions:

#2. 4-6 hrs per day

#3. approximately 15-20

#4. 8-10

#7. No based on my own personal actions with Mr. Marcotte and letters from area business owners that she can obtain while Mr. Marcotte was under her supervision #8. No due to her experiences with Mr. Marcotte and his disrespect for her authority as a broker

Commissioner Cymbaluk moved, seconded by Commissioner Sheridan to table Mr. Marcotte's application for a broker license until the Commission has had the opportunity to review a minimum of 3 letters from Ms. Tweten and letters of reference from Mr. Marcotte. M/C Each side was also asked to provide information on Mr. Marcotte's listings and sales.

- 5. REVIEW TABLED APPLICATION OF JULIA E. SAMMON. Ms. Sammon's application for a reciprocal salesperson license was tabled at the October 27, 2015 Commission meeting until Ms. Sammon provided an explanation as to why the charges which appeared on her background check were not disclosed on her application. Ms. Sammon provided the requested information to the Commission. Commissioner Cymbaluk moved, seconded by Commissioner Sheridan to approve issuing Ms. Sammon's reciprocal salesperson license. M/C
- 6. OTHER BUSINESS.
 - a. Commissioner Sheridan stated she would like the Commission to discuss establishing a policy to provide guidelines for staff to approve applications with certain issues on their background reports that would then not need to come before the Commission. The Commission asked staff to research how many applications were denied in the past year and the reason why.
 - b. The Commission discussed possible dates for the next Commission meeting. The end of March would work best for all Commissioners.

There being no further business Chair Youngberg adjourned the meeting.
